Dear Families:

The District is committed to protecting the health and well-being of our students, teachers and staff. In compliance with the New York State Department of Health (NYS DOH) regulation titled *Lead Testing in School Drinking Water* (10 NYCRR Subpart 67-4), we recently performed an updated inventory of all water outlets in the school district and another round of sampling of all applicable water outlets. As you may be aware, these water outlets were previously tested in 2016.

Sampling of potable water outlets (water outlets used for cooking or drinking) was performed by our environmental consulting and testing firm. In an abundance of caution, the district also sampled non-potable outlets (water outlets not designated for cooking and/or drinking) throughout the school buildings. While not typically used as drinking water, it was decided that the sampling of these non-potable outlets be performed in the rare instance that a child might use them for drinking.

A total of 613 outlets were sampled district wide. Only 4 of the water outlets designated by the district for drinking or cooking revealed concentrations of lead above New York State's action level of 15 parts per billion. We would like to note that there has been no student access to these locations since the beginning of the school year. These outlets have been removed from service until remediation/repairs are performed and re-testing results document acceptable concentrations of lead.

All other outlets which revealed concentrations of lead above the New York State's action level of 15 parts per billion are not used for cooking and/or drinking and signs have been posted noting their restriction.
